 parties, except where such interests are overridden by the fundamental freedoms and
 rights and interests of the data subject. Legitimate interests include, in particular, our
 commercial interest in being able to provide our website, information security, the
 enforcement of our own legal claims and compliance with Swiss law.

We process personal data for the duration necessary for the respective purpose or purposes. In the event of longer-term storage obligations due to statutory and other obligations to which we are subject, we shall restrict processing accordingly.
